AFS Awards – Selection Criteria

Category	Criteria
Honorary Member Award	To be awarded to individuals, teams or institutions who have made (a) highly significant contribution to Asian aquaculture/fisheries sciences over a long period of time and whose work have major impacts on sustainable aquaculture and fisheries research and development in Asia and/or (b) significant contributions that have tangible and long term impacts on the operation and status of the Asian Fisheries Society
Criteria for Gold Medal Award	To be awarded to individuals, teams or institutions who have made significant and consistent contributions to the Asian Fisheries Society. Contributions may be scientific, services, material, monetary or in kind. These contributions normally are important enough to be recognized but not sufficient to be given the Honorary Member award
Criteria for Merit Award	To be awarded to individuals, teams or institutions who have participated and contributed to successful activities of the Asian Fisheries Society. Contributions may be scientific, material, services, monetary or in kind and are important enough to be recognized but not sufficient to be given the gold
Criteria for Appreciation Award	To be awarded to individuals, teams, or institutions who have assisted and contributed to aspects of the Society's operational activities e.g. assist in workshops, conferences etc. Contributions may be scientific, material, services, monetary or in kind and are important enough to be recognized by the Society

Procedures for Nomination and Selection:

- 1. Nominations shall be accepted from only fully paid up members of the Society;
- 2. All nominations shall be submitted in writing on the AFS Nomination Form available on the AFS website to the Executive Office of AFS before the closing date;
- 3. The Award Committee of the AFS shall finalize the list of recommended candidates within two months from the closing date for submission and submitted to the Executive Committee for approval; the final list to be approved by the Council;
- 4. The successful candidates shall be informed of their awards at least three months before the triennial forum; and
- 5. The decision of the Council shall be final and no negotiation will be entered into or allowed.
